Preamble:-

WHEREAS, Ghulam Ahmed College of Education, Banjara hills, Hyderabad has submitted application for Additional intake in B.Ed course on 8.5.2010.

AND WHEREAS, Deficiency letter was issued to the institution on 22.12.2009. The institution submitted its written representation on 2.3.2010. The reply for deficiency letter was placed before SRC in its 190th meeting held on 29-30 March 2010 and SRC decided to cause inspection. Accordingly, inspection was carried out to the institution on 8.5.2010.

On careful perusal of the original file of the institution, Visiting Team Report, Video CD, other related documents, Act of NCTE, 1993, Regulations and guidelines of NCTE published from time to time laid on the table, written representation from the institution. the Regional Committee decided to refuse recognition to the B.Ed. course for the following reasons:-

- The institution is already having B.Ed. course, D.Ed. course and M.Ed. course. Total built-up area is 3804 sq. mtrs. As per norms of NCTE, 3500 sq.mtrs. is required for the existing courses and 500 sq.mtrs. additional built up area is required for the proposed course.
- MBA , Law College, Junior College, Pharmacy College, a public school and Engineering College are all run in the same educational complex with separate demarcation of land/ building for the Teacher Education courses.

As per the decision of SRC, Refusal order was issued to the institution on 31.05.2010.

Institution has filed appeal Under Section 18 of NCTE Act, before the appellate Authority, NCTE, New Delhi against the refusal order dated 31.05.2010.

The appellate authority vide order dated 17.09.2010 has reversed the order of SRC with the direction to process the case as per regulations...

The Committee considered the appellate authority order and decided to consider the reply of the institution and all the relevant documents and process the application for enhancement of Intake to B.Ed by 40 students; it is decided to enhance the intake making the total as two units of 100 each.

WHEREAS, Sulthan UI-Uloom Education Society, Hyderabad, Andhra Pradesh had applied for grant of recognition to Ghulam Ahmed College of Education, P.No.8-2-249, Shaikpet, Banjara Hills, Hyderabad, Andhra Pradesh for B.Ed-Al course of one year duration under section 15(1) of the NCTE Act, 1993 to the Southern Regional Committee, NCTE on 28.10.2009.

AND WHEREAS, Deficiency letter was issued to the institution on 22.12.2009. The institution submitted its written representation on 2.3.2010. The reply for deficiency letter was placed before SRC in its 190th meeting held on 29-30 March 2010 and SRC decided to cause inspection. Accordingly, inspection was carried out to the institution on 8.5.2010.

- 2. On careful perusal of the original file of the institution, Visiting Team Report, Video CD, other related documents, Act of NCTE, 1993, Regulations and guidelines of NCTE published from time to time laid on the table, written representation from the institution, the Regional Committee decided to refuse recognition to the B.Ed. course.
- 3. AND WHEREAS the Correspondent, Ghulam Ahmed College of Education (hereinafter referred to as the appellant), preferred an appeal dated 08.07.2010 to the National Council for Teacher Education, New Delhi (hereinafter referred to as the Council) under Section 18 of the NCTE Act, 1993 against the said Order.
- 4. AND WHEREAS having considered the verbal submission by the representative of the institution, the written representation, the original record of the case and V.T. Report, the Council decided to reverse the order of SRC for the reasons recorded in the Appellate order dated 17.09.2010. Accordingly, the appeal was accepted and reverse the SRC order dated 31.05.2010
- 5. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to **Ghulam Ahmed College of Education, P.No.8-2-249, Shaikpet, Banjara Hills, Hyderabad, Andhra Pradesh** for conducting **B.Ed-Al** Course of one year duration with an existing intake of 160 and an additional intake of 40 thus making annual intake of 200 from the academic session 2010-11 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2007 subject of fulfillment of the following conditions:
- i. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or Mortgaging of FDRs shall not be done.
- ii. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.

- iv. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- 6. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.
- 7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - (i) Copy of the Application Form
 - (ii) Land and Building Particulars
 - (iii) Staff Profile
 - (iv) Recognition letter
 - (v) Information for having fulfilled the norms & standard and other required conditions.
- 9. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
